A new data privacy law

From May 25, 2018, the General Data Protection Regulation, known as GDPR comes into effect. It is the biggest change to data privacy law for 20 years and creates a single set of rules that aim to better protect your personal information. This new regulation allows you to have more control over your data and introduces higher quality standards on the handling, processing and storage of your personal data.
